PLACE ----- AYNOR TOWN PARK (1 BLOCK OFF HWY. 501)  
DATE ----- SATURDAY, SEPTEMBER 21, 2024  
TIME ----- 9:00 A.M. 'TIL 5:00 P.M.  
SIZE OF SPACE ----- APPROXIMATELY 12 FEET BY 12 FEET  
COST PER SPACE -----\$75.00 (Applications received without funds will be promptly returned.)

**(NO applications will be accepted after September 16, 2024.)**

1. The reservation fee is **non-refundable, unless Festival is cancelled due to an act of God.** If weather prohibits the Festival from taking place, there is **NO** alternate date.
2. **WE DO NOT PROVIDE: ELECTRICITY, TABLES, CHAIRS OR SHADE.**
3. **NO GENERATORS ARE ALLOWED.**
4. Set up time is from 6:00 A.M. until 9:00 A.M. You may drive a vehicle inside the park to unload; but **all vehicles and trailers must be outside of the vendor area by 9:00 A.M.**
5. **NO MOBILE BOUTIQUES, TRAILERS, GOLF CARTS, OR OTHER VEHICLES WILL BE ALLOWED TO REMAIN ON ANY VENDOR SPACE, EXCEPT FOR FOOD TRAILERS. Mobile Boutiques are only allowed on the Conway National Bank Lot.**
6. Anyone who wants to put a tent up on Friday may do so **AFTER 2:00 P.M.** The Festival is not responsible for the tents overnight. The park has a brick walking path. Please bring weights and stakes to set up tents.
7. Our spaces are **approximately 12 feet by 12 feet.** If you are renting a tent, please check the size carefully with the rental agency. Some agencies do not carry a tent size that will fit our spaces, but others do carry the appropriate size.
8. We reserve the right to limit the number and types of entries. We reserve the right to reject any and all applications.
9. Foods and crafts may **NOT** be sold from the same booth. **Do not sell or give away water.**
10. **NO ALCOHOLIC BEVERAGES** will be permitted in any of the booths. If we find it available, the police will be notified and the police will remove it.
11. **NO PETS.**
12. There will be no sharing, subleasing or subdividing of a space or spaces.
13. Violators may be asked to leave and will not be invited back the next year.
14. South Carolina Sales Retail License is required by South Carolina Law.
15. Closing time for the Festival is **5:00 P.M.** Please do not begin closing booths until **5:00 P.M. NO SALES AFTER 5:00 PM.** Vehicles can be brought into the vendor area **after 5:30 P. M.**
16. **All vendors must be out of the vendor area by 7:00 PM.**
17. **Vehicles in the parade will not be allowed into the barricaded vendor area.**
18. **VENDORS WILL RECEIVE WRITTEN OR ORAL CONFIRMATION.**

19. Please do **not** drive down the brick walking path in the Aynor Town Park.
20. **Do not bring any toy guns that look like real guns. The Aynor Police do not want these items brought to the Festival this year. No Knives.**
21. **No tobacco products, vape products or CBD products allowed.**
